THIS PROGRAM DID NOT OCCUR IN FISCAL YEAR 2021 DUE TO PANDEMIC IMPACTS BUT WAS REPLACED BY VIRTUAL PROGRAM SERIES THAT CONTINUED TO UPHOLD THE MISSION TO PROVIDE NETWORKING AND TRAINING OPPORTUNITIES FOR THE MEMBERSHIP.
